Payment

In consideration of the Fee, Sydney Golf Australia (SGA) will make all Arrangements for Play at the Preferred SGA Course at the Preferred Tee Time or as close as possible to the Preferred Tee Time.

All payment details must be fully completed on the 'Guest Request Form' to confirm a booking with SGA. This includes your name and signature for authority for the Hotel Concierge to charge payment to your hotel account OR for credit card payment the card number, name on the card, card-holder's signature and expiry date on the card.

Cancellation and refunds

A cancellation fee of 100% will apply to All confirmed bookings, adverse weather conditions or no show.

If a golf course at which Play is to occur is declared unplayable by that golf course, and that golf course refunds SGA any amount, SGA may, in its absolute discretion, refund a proportion of the Fee to you as SGA sees fit.

General

You understand and acknowledge that:

No fault is accepted by SGA for the cancellation or moving of tee times by SGA golf courses. SGA will use its best endeavours to find alternative tee times or courses as a replacement where possible.

Electric golf carts may not be allowed due to wet weather and that courses may be walking only if still open in these circumstances.

Strict dress regulations apply at SGA courses. No fault is accepted by SGA if loss of play or incidental cost is incurred by you due to unacceptable dress. (For a copy of the "Australian Dress Regulations" please contact your Hotel Concierge.)

If the Fee includes the provision of Equipment from SGA, you agree to pay the retail cost of any item of Equipment damaged or lost whilst in your care, custody or control.

SGA accepts no responsibility for the condition of playing tees, fairways or greens at an SGA Golf Course or for the timing of maintenance programs such as coring of greens and fairways, however SGA will endeavour to pass on any relevant information it receives in relation to such activities.

You agree and acknowledge that you will not hold SGA responsible or make any claim with respect to any injury or loss you may suffer while playing golf or accompanying a golfer at an SGA Golf Course.
